Reflections

I f we do not capture past lessons, we may not appreciate the actual state of affairs. To this end, I (the editor) decided to periodically memorialize some of my experiences. Forward: The news suggests that electronic voting machines used in the 2020 election were secure [1]. Indeed, the former head of the Cybersecurity and Infrastructure Security Agency (CISA), Chris Krebs, defended the security of the election systems and processes [2]. The question here is how could anyone know? Consider, on his watch (Chris Krebs), a significant security breach that compromised many US Government agencies went undetected for months [3]. The hacking targets also included the agency he headed, the CISA [4]. So if CISA systems are being hacked undetected, how can a statement be made that voting machines are secure? The argument is non sequitur.

Recall the Office of Personnel Management (OPM) data breach of background investigation materials [2]. The attack appears to have come from China and was undetected for so long, the initial date of compromise remains a mystery [5]. Forensics indicated a failure in senior management to implement adequate security [6,7].

My contribution follows. Prior to the OPM fully taking the lead on background ingestions; I made the cut for a GS-15 candidate job interview. In attendance was a senior and mid-level manager conducting my interview. They mentioned they were planning to become the lead agency for background investigations and asked how I would ensure security. I explained how the Federal

Deposit Insurance Corporation (FDIC) where I worked had implemented a (Continued on page 2)

he number of COVID-19 deaths in the US passed the 300,000 mark [1]. While the US waited for the FDA's Pfizer approval; Canada approved the vaccine [2]. This came as the UK continued vaccinating its people with the vaccine [3]. Then on December 10, the FDA sponsored panel of outside experts endorsed the Pfizer vaccine on a 17 to 4 vote [4]. Finally, on December 12, the FDA approved the Pfizer vaccine emergency use authorization.

Meanwhile, COVID-19 continued to expand. In Japan and South Korea, after containing the virus, new outbreaks were reported [5].

Elsewhere, China announced plans to import 100 million doses of the vaccine co-developed by Pfizer [6]. This comes as one report indicates China downplayed the virus and overstated its response to the pandemic [7].

Then on December 18, the FDA approved Moderna's COVID-19 vaccine emergency use authorization [8].

One consequence of a delayed vaccine implementation is the virus has had time to mutate. For instance, in Nevada, a new mutation of the COVID-19 virus was discovered [9]. In another example, a new strain of COVID-19, referred to as VUL-202012/01, appears to be more infectious and is spreading in the U.K., Australia and continental Europe [10]. What's more, the new strain appears to be spreading. For instance, the new virus was detected in Japan for the first time [11]. Another report indicates the new variant has also been detected in Canada, Spain, and Sweden [12]. Additionally, China has banned all flights coming from the UK [13].

Economy

The value of stocks remained high. For example, on December 7, the Nasdaq composite closed at a new record high [1]. Then on December 8, the S&P 500 and Nasdaq set record high closes [2]. On December 17, the three major stock indexes (S&P 500, DJIA, and NASDAQ) closed at record highs [3].

The consequences to the US economy due to COVID-19 are obvious. For instance, one piece suggests China's economy will overtake that of the US in 2028, five years earlier than expected [4]. Additionally, due to the impact of COVID-19, state and local governments are not getting funding they need [5].

A good indicator of the weak economy can be seen in the bleak unemployment claim numbers. The first time unemployment rate for the week ending December 5 was 853,000 [6]. For the week ending December 12, the number rose to 885,000 [7]. For the week ending December 19, the number reported was 803,000 [8].
